### ***President's Report:***

The Board of directors have been addressing our revised 2017-2018 priorities. We have been working on all of them by preparing position papers, seeking meetings with the appropriate ministers, and sharing our priorities with the PIA, Seniors Working Group.

The Board is seeking a meeting with the Honourable Lori Sigurdson, Minister for Seniors and Housing. We plan to present our revised priorities and to present her with our position paper on stable affordable housing concerns, in the province of Alberta.

The Board is also seeking a meeting with the Honourable Joe Ceci, President of the Treasury Board and Minister of Finance. We will also present our priorities with emphasis on a position paper, recommending increasing COLA (Cost of Living Adjustment) to 100%.

PharmaCare continues to be a priority for the government and SUN is monitoring the governments planning process and is involved in the current group discussions on pharmacare proposed changes for the future. Our Executive Director, Linda Osborne, is a member of the Alberta Pharmacare Working Group and keeps the Board apprised of the direction the working group is taking. SUN's position is that all seniors must receive the same benefits, regardless of their income. We all paid our taxes and should enjoy equitable benefits.

Home care services in the province continue to be inadequate to meet the current need for services. SUN is receiving increased complaints that wait times for receiving services are getting longer, there appears to be a cut back in approved services, and seniors are not receiving the help they need to remain in their homes. Alberta continues to grow in population, which means that the number of seniors also grows each year. Home care funding and service availability are not keeping up with this growth. The outcome of inadequate home care is that seniors must be admitted to a hospital to have their needs met. This is expensive and does not assist aging in place.

Continuing care is plagued with long waiting lists and access is difficult to achieve. As the government moves from continuing care being delivered by private companies to facilities being managed by Alberta Health, the question is, will this move increase available beds or just maintain the status quo? The promise of the government is that their projects will put residents' interests in the forefront. This is great, but if there is not an improvement in access or in quality of life for residents, while operating costs increase, then nothing would have been gained over the status quo. We need improvement in the system - not a different way to do the same thing. We trust that system improvements are a major objective within the planned government changes.

The board continues to advocate for our members, both on an individual basis and for increased financial and life style benefits for all seniors in Alberta. We are working on your behalf to be the "Voice of Seniors" in Alberta. As deficits rise, we are concerned that services may be cut to lower these deficits.

The board will continue to monitor the situation and appreciates the continuing support we receive from our membership.

## ***Pension Advocacy Update***

The Board of Directors have requested a meeting with the Honourable Joe Ceci, President of the Treasury Board and Minister of Finance.

The purpose of the meeting is to introduce our organization, present our 2017-2018 priorities and to discuss our position paper, which recommends, how the annual cost of living adjustment (Cola) could be increased to 100% without the government having to use tax dollars to fund a 100% cola each year.

The benefit of our recommendation is that seniors, on a fixed pension income, could continue to have the same purchasing power for goods and services from year to year. When a senior's income continues to fall behind inflation, their ability to maintain their current life style is compromised. We are advocating that all seniors have the right to remain in their home for as long as possible. This is the hope we all have, and it saves tax dollars as seniors live a fuller life in our homes.

## St. Albert Gazette Article – Showcases local Chapter

The upcoming municipal election is a prime time for residents to raise issues of concern to candidates. For one group of local seniors, affordable housing is at the top of the agenda, joined by ongoing concerns with taxation, health and more.

Formed in 2002, and with chapters province wide, Seniors United Now (SUN) maintains a dynamic chapter in St. Albert, about 150 members strong, who have no problem getting their message across to city or provincial government representatives.

The non-profit advocacy group has about 2000 Alberta members. The St. Albert Chapter members meet monthly to hear speakers on issues from property taxes and transit to the local hot-button matter of affordable housing. In a city with approximately 13,000 seniors and growing. SUN points to the glut of traditionally large single-family homes that don't reflect the growing number of seniors who want to downsize to smaller homes or move to affordable apartments and condos. "Advocating for housing diversity is a key priority for SUN, and a key part of our action plan going forward." Says Dick Tansey, chair of the SUN St. Albert Chapter. "We've still got very few affordable apartment buildings for independent seniors, and a real lack of smaller bungalows. There are seniors living in the gap: those who aren't in assisted living or long-term care (programs with government assistance) but who are independent and pay more than 30 per cent of their income toward rent. Many want the option of a smaller house, but the developers have no incentive to create it."

Tansey says SUN is finalizing a report that it will present to the city, asking for councillors to consider offering financial incentives to those developers who will address that segment of the market looking for affordable, smaller bungalows – a sought-after alternative to renting or buying apartment style condo suites. The group also plans to bend the ear of every council candidate with a late September meet-the-candidate forum, (open to all) and which will follow a speed-dating-type format. Each resident can spend five minutes in a one-on-one setting with a candidate to see where they stand on such issues as affordable housing.

SUN has a track record of getting things done. The group pushed government to create the Seniors Property Tax Deferment Act, which allows senior homeowners struggling financially to defer such payments – along the lines of a reverse mortgage, says Tansey. It helps independent homeowners stay in their own homes longer. "Sometimes it's a house rich but cash poor scenario". Letter-writing campaigns and presentations can be two steps forward and one step back, but our advocacy does create change. We're the voice of seniors in Alberta, and there's strength and power that can come when all voices are united in one large group. We can have an impact.

### LONG WAIT LISTS

Tara Burnett outreach supervisor with the St. Albert Seniors association (the former 50+ Club), say she's well aware of the high monthly rental costs at several local seniors' complexes (upwards of \$2,000 and \$3,000) and the long wait lists (a year or more) at the more affordable spots in town. "It's an issue of great concern to our membership too. We like to meet our members wherever they're at – as involved as they want to be – so sometimes that's a presentation here. I've also done talks at SUN on transportation and elder abuse. SUN is vibrant and well-informed and is an outlet for seniors who want to be an active part of the issues. Ultimately, SUN's work also supports our own goal of keeping local seniors engaged, not isolated." Burnett says.

At monthly meetings, SUN brings in speakers on a wide range of topics: library services, legal matters (personal directives / wills) as well as working on broad issues such as the Human Rights Act. Whether with email or letter writing campaigns to MP's or MLA's, the group is working on age-discrimination at 55-plus housing facilities, maintaining medical exams for drivers over age 75, and even goods and services like seniors' discounts at recreational facilities.

## Health, senior & labour groups forge agreement on pharmacare campaign in Alberta

Representatives from health, seniors' and labour groups in Alberta will be joining organizations across Canada to make pharmacare an election issue at upcoming provincial and federal elections.

The groups responded to a call issued by the Alberta Federation of Union Retirees (AFUR) to meet at United Nurses of Alberta Edmonton headquarters earlier this week to explore ways of working together toward a universal prescription drug plan. They agreed to work from a common calendar, aimed at applying pressure on Alberta and the Federal government to implement such a program by 2020.

Representatives from the Canadian Labour Congress (CLC) and the Alberta Ministry of Health presented elements of a universal prescription plan that would achieve accessibility, universality and other features of a comprehensive plan. It was agreed that these would be focal points in a campaign to begin in early 2018 under the direction of a working group that would coordinate actions, resources, and tools of engagement.

According to AFUR President Lucien Royer, the agreement this week builds on a growing number of organisations and social movements across the country that are determined to make pharmacare a reality, in unison with public health care

“National organisations such as the Canadian Health Coalition (CHC), Canadian Labour Congress (CLC) and the Congress of Union Retirees of Canada (CURC) have already made it a national priority and many more are joining the effort” he said.

“We know that 92% of Albertans support a universal program, and we are therefore upbeat about the positive momentum for change and the prospects it presents for common strategies to coalesce at upcoming elections”.

AFUR is the provincial body that coordinates the work of CURC in Alberta. It coordinates the efforts of local area councils across the province. Follow up to this weeks meeting is already planed by at a special dinner of the Edmonton Area Council this Sunday 10 December 6:00 pm. **Public discussion about Alberta's carbon tax tends to raise two important subjects for discussion: the urgent need for action on climate change and the severe shortage of tax revenue in our province.**

On both, the provincial government's actions have been cautious and highlight the need for much more work to be done. However, the carbon levy as it is currently designed is an essential step in the right direction after decades of inaction on climate change.

Every political leader in Alberta agrees, at least in word, that human-caused climate change requires government action.

While a carbon price is not a silver bullet for tackling climate change, a plan without one would have limited impact in achieving the goals required by climate science. The most common argument against the carbon tax in Alberta is an economic one. However, nearly every economist in the world favours putting a price on carbon.

We have precedents to draw from to ensure the policies we adopt are effective both for combatting climate change and for boosting the economy. In 1991, Sweden introduced a carbon tax, which sits at \$200 per tonne today. Their economy has continued to grow at a pace similar to Alberta's, and their greenhouse gas emissions have decreased by nine per cent over that time.

The very limited action the previous government took in Alberta, mainly very expensive carbon capture and storage projects, had negligible effect by comparison. Over the same period, Alberta's emissions increased by 150 per cent. Clearly, the status quo was not working.

Alberta's carbon tax, implemented this year, started at \$20 per tonne and, following the federal government's upcoming floor price, will grow to \$50 per tonne by 2022. Alberta's carbon pricing may need to be even more ambitious than planned to achieve the emissions reductions required by climate science. Such progress need not be at the expense of the economy.

The key is to reinvest the revenue in measures that both reduce greenhouse gas emissions and spur economic growth. Investments in energy efficiency create significant numbers of good jobs and reduce emissions at the same time. Making homes and workplaces more energy-efficient also reduces power and heating bills. Alberta's climate plan puts a high priority on these measures through the creation of the Energy Efficiency Alberta agency and related programs.

The most significant piece of climate change policy our province still lacks is a way to track progress on reducing emissions. The government plan does not include specific targets or estimates of how much each measure will reduce greenhouse gas emissions. We need much more accountability for how well the plan is working.

Some say a carbon tax should be revenue neutral, meaning other taxes are cut to prevent an increase in overall government tax revenue. Not only would that prevent the above government actions from happening, but when Alberta is short roughly \$10 billion in annual operational revenue, it makes little sense.

Alberta's tax system is by far the worst in the country at raising revenue to collectively pay for public services Albertans want, need, and value. A recent poll commissioned by the Parkland Institute shows 66 per cent of Albertans support a carbon tax if the funds are used to invest in public services like health care and education.

Even if some carbon tax revenue is, at least in the short term, allocated to help address our province's revenue shortage, a more extensive conversation is needed. The tax systems of other provinces would raise between \$8.7 billion (British Columbia) and \$22.4 billion (Newfoundland and Labrador) in additional revenue if adopted in Alberta. We need a broad public discussion to figure out a fair way to close that gap to protect and strengthen our public services.

Alberta's carbon price is a cautious step in the right direction. It is necessary to make any real progress on preventing or even mitigating climate change, and those who oppose a carbon price need to state clearly what alternative measures they favour. The global transition away from emissions-intensive industries will not happen overnight, but it has already started, and any political leaders ignoring it are doing a disservice to Albertans and our future.

Our steering committee strives to keep our membership informed on local issues which include: property taxes, user fees, utility costs, transportation and affordable housing. **What's Happened...**

**January 22, 2018** Our guest speaker, Melany Fuller of the local Primary Care Network office gave an excellent presentation on the benefits of **"A Prescription to Get Active"**. It is a motivational program proposed to assist our seniors to remain healthy as long as possible, to avoid isolation and to reduce stays in hospitals and intuitions. Importantly, it is free or of low cost. All one must do is to see their doctor or health professional to get started. Servus Place and GoodLife Fitness offer programs designed to help seniors in St. Albert. Indoor malls and walking trails are available in our area to anyone who wishes to get fit on their own or in groups. Household duties help one get chores done while remaining active. Thirty minutes five times a week is all that it takes. Benefits include prevention of diabetes, strokes, colon cancer and cardio vascular issues as well as feeling strong mentally. **February 26, 2018** **"Office of the Seniors Advocate Year in Review"** by Leslie Sorenson, Seniors Advocate Representative Leslie gave a power point presentation of the first nine months of operation, since inception in September 2016, under the leadership of Dr. Sheree Kwong See.

The purpose of this semi-independent agency is to link seniors' issues with resolution, to analyze causes and to initiate changes to existing seniors' policies. There are similar Advocacy groups in B.C., NL, N.B. all with varying goals but not as comprehensive as in Alberta. The annual report which covers all of Alberta, handled 562 cases with 2500 contacts via phone, email and website. Income support, House and Home support, Social support and Health Care Support are the basic categories addressed. Ageism advocacy is required across ministries, advocacy for a housing **"Direct to Tenant Rent Supplement Program"** and advocating for consistent messaging in all departments is ongoing. Seniors housing under Bills 10 and 22 is given input. Seniors' councils could be set up in each resident community to help alleviate issues between tenants and landlords. The audience queried mental and financial abuse, intake of unqualified staff without proper attitude and training, lack of accountability and deteriorating intergenerational respect and learning.


