Anglican Church. Gordon is married, with 1 son, 1 daughter and 2 grandsons.

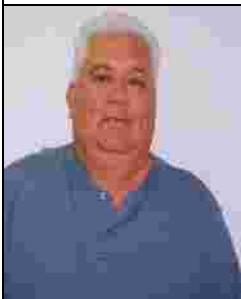


Richard (Dick) Tansey – Vice- President
