It is with great sadness that we share the announcement of the passing of Seniors United Now long-time volunteer and current President Gordon Voth.

The Seniors United Now Board of Directors met on June 1st and took time to reminisce about Gordon's years with SUN. We thought about his leadership and how he skillfully led in some very difficult times; the creative direction he gave to Seniors United Now over the years to help SUN adjust to changes in government, changes in the senior's environment and "the new way to operate" with COVID-19.

Gordon became a member of Seniors United Now during its start-up in September 2003, he then joined the SUN Board of Directors as Treasurer in October 2004. Over the following eighteen years, Gordon remained active on the SUN Board of Directors in various positions.

For Seniors United Now to no longer have the friendship and leadership of Gordon at the helm, is a great loss, for the Board of Directors, SUN staff and the entire membership of Seniors United Now. His celebration of life took place on June 7th.

Review of AGM April 27, 2022

The Board of Directors called a zoom AGM meeting on April 27, 2022. Unfortunately, we did not have sufficient members signing in to declare that a quorum was in attendance. A quorum consists of 50 voting members and the majority of the board be in attendance. I am pleased to advise that the entire board was in attendance.

As there was no quorum, as chair I was required to declare that the meeting would be an information meeting only. There would be no voting on motions from the board. Reports from the President, Executive Director and Treasurer were received as information.

Under the societies act, the board of SUN is required to call a Special General Meeting with in 18 months of the last approved AGM. The board has set October 12th for when the special general meeting will occur. The meeting will be an inperson meeting. The board will present a short business agenda. The agenda will include motions to approve of the minutes of the April 28, 2021, AGM, financial reports, appointment of auditors and confirmation of proceedings.

Following the business meeting, the board plans to conduct a social program that will include volunteer recognition, chapter recognition, strategic planning feedback and information presentations. In addition, to make the morning more enjoyable, we will have draws for door prizes, and a 50/50 draw. This event will be followed by a luncheon. Please plan on attending this important but enjoyable event.

Presidents Report

The past two pandemic years have caused many seniors to cocoon and wait. First for a vaccine to help protect us from Covid-19 and for a return to our old way of life. Visiting friends and relatives, travel without worry, a return to a past normal. However, with every passing phase of Covid, we are now in wave six, it is becoming evident that we will not return to our old normal but rather will have to plan for a new normal.

With this premise in mind, your Board of Directors have commenced reviewing our existing strategic plan and developing a new process to identify what are the most urgent issues we should be addressing over the next year. We have looked at how we list our priorities and how we will organize them. As of this date, we have agreed to list all priorities under three broad headings.

They are: Financial security, Health status, social isolation

Within these three categories, we will list our identified objectives. These are issues that need attention to achieve improvements in our broad priorities. Some examples are stable affordable housing, home care services, long-term care shortages, pension reform, community services that assist seniors to be more mobile, a pharma care program. To be successful, these examples will need the joint participation of all seniors' groups and the Alberta government. We believe that to be successful we need a strong senior voice and a cooperative participation from the Alberta government. We must not be seen as opponents of the government.

On a financial note, SUN has survived 2021 by cutting back on services and reducing our operating budget. A large part of our reduced costs has been from our staff voluntary reducing their hours of work and declining any salary increases. For this action, the board is extremely grateful. We all owe our staff a great deal of thanks for helping SUN survive.

Our fund-raising appeal to the membership has been successful and will help us to continue to operate until the April 11 and 12 casino funds are received. We anticipate the cheque will arrive in August or September. The Board of Directors extend our thanks to all those members who responded to our appeal for bridging funds. It demonstrates that you the membership want SUN to continue to be your advocate. I am sorry to report that our application for a Community Initiative Program Grant, in the amount of \$40,000. has been declined. It is a setback, but we will continue to operate. It means that we will not be able to return to a fully operating office until the casino funds are received. A special thanks to all the members who volunteered their time to work the casino. Without these dedicated members, SUN could not continue to operate and effectively advocate on your behalf.

Based on membership feedback, we will continue to hold zoom chapter meetings and plan on a return to in person meetings in September 2022.

I personally look forward to the time when financial shortages and Covid management is not our most pressing issues. SUN will then be able to develop a new path to the future and rebuild a working partnership with the ministers of the Alberta government.

I suggest that we must continue to look for good news. Remember, a vaccination has been developed and that will provide protection from this pandemic. We must persevere until then. Seniors are hardy, have experienced hard times before and have the resolve to do what is needed.

Alberta Seniors United Now Society Proposed Bylaws Changes

The Alberta Seniors United Now Society are requesting members to register for the October 12th, 2022, Special Annual General Meeting. We need to achieve a Quorum of 50 (fifty) current members to vote on the following proposed Bylaws changes.

By-law Article III Executive Officers and Directors #6 (bullet point 5)

•all terms of office shall be for two years or until their successors are elected, with one half (1/2) each of the Executive Officers and the Directors to be elected on alternate years.

proposed change

By-law Article III #6 (bullet point 5)

- An officer shall hold office until the earlier of:
- (a) the officer's successor being appointed, (b) the officer's resignation, (c) such officer ceasing to be a director (d) such an officer's death.

proposed change (new)

By-law Article III #7 Executive Director shall be deemed to be the authorized executive representative of SUN

The executive director shall have authority from and responsibility to the Board of Directors for the day-to-day operations and management of the affairs of SUN subject only to the Act and Regulations governing Societies in Alberta, these Bylaws, and parameters set by the Board of Directors. Such authority and responsibility may be sub-delegated by the Executive Director to any other staff member as deemed appropriate by the Executive Director.

The Executive Director shall be an "ex-officio" voting member of all SUN committees except for the Planning Committee and the HR Committee when issues relate directly to the Executive Director.

By-law Article IV - Meetings #5 The majority of the Board of Directors and *fifty*(50) of the general membership shall constitute a quorum at any general or special meeting.

proposed change

By-law Article IV - Meetings #5 The majority of the Board of Directors and *twenty-five*(25) of the general membership shall constitute a quorum at any general or special meeting.

proposed change (new)

By-law Article V – Committees #3 Executive Committee - is made up of the Executive Officers with the SUN Executive Director as an ex-officio member. The Committee acts as a steering committee for the Board of Directors (Article III). Its main purpose is to facilitate decision-making between board meetings or in urgent and crisis circumstances. It has the power to act on behalf of the Board. It prioritizes issues for the Board to address, is responsible for overseeing Board policies and must ensure good governance practices.

Sherwood Park / Strathcona County Chapter (SPSC) WHATS HAPPENED?

March 15,2022 - **Topic:** At Your Fingertips_Presenter: Sylvia Hertling, Information Specialist, from the County of Strathcona Library shared with us her best kept secrets (free resources) you can find at the library and there were many of them. A community notice board is available at the library entrance for anyone who wants to use it along with brochures of various organizations are there to pick from. A Seniors Corner is also offered for "everything seniors related." Finger Puppet Kits, Story Time Kits, Sports kits may be very helpful to seniors with active grand kids. Inter-library loans enable readers to procure books from other libraries. Access to online seniors' magazines (Overdrive), computer tech team help, accessible large print books (CELA, NNELS), and audio books are also at your disposal. Scan free documents, research tools such as Ancestry.com and Consumer Reports are all free online through the library. Many online courses such as Homework Help, Creative Bug (crafts to cooking), Linked in Learning, Pronunciation and Language Learning tools including ESL and kits for dementia are all resources made available with a free library card.

May 17, 2022 What does it take to build a hub of services for seniors in Strathcona County?

Speaker: Nicole Wilke, Senior Project and Policy Coordinator, Strathcona County

Nicole gave us the good news that based on a previous needs assessment the county was in the process of hiring a non-profit organization to partner with the municipality to meet a broad mandate to advocate, coordinate and provide programming and connection opportunities for seniors in Strathcona County. To this end the county had allocated 200,000 dollars per year for three years to fulfill this mandate. It was also pointed out that Strathcona County has one of the fastest growing demographics of seniors in Alberta and that by 2031 the population over age 65 will be 25 percent of the total population. The Senior Advisory Committee has also been studying and visiting the Edmonton area to see how other senior's center's function. There are presently three seniors' centers operating in the County (Sherwood Park, Josephberg, and Ardrossan). Important considerations for a new seniors' hub need to focus on: belonging, convenient access (related to technology, transportation, and physical accessibility) and affordability. Outreach supports and services will be the primary mandate of the chosen non-profit. **New Developments** – On the positive side since Nicole Wilke delivered her talk the West Edmonton Seniors Centre (WE) has been chosen by the County to be the non-profit in charge of developing the new mandate. On the negative side the proposed new senior's hub was put on hold indefinitely due to budgetary restraints based on of capital projects such as The Pointe (the new Agri center), the new field house and the new foot bridge linking Strathcona County to Edmonton. SUN will have to continue to monitor and advocate for a new Seniors Complex in Strathcona County as more seniors will continue to travel to Edmonton to obtain some of the services that the County will be unable to provide.

WHATS UPCOMING?

Great News! Our chapter is planning to resume in person chapter meetings in the Fall. Sherwood Park and Strathcona County SUN chapter has been awarded a community renewal grant to help restore some of the damage caused by COVID-19 and restart our Chapter. We are planning a luncheon to kick-start our membership renewal and will be inviting anyone who would like to attend our first meeting.

September 20, 2022 Topic: Fall Prevention for Seniors

Speaker: Cole Gunderson, BSc Kin, ACSM-certified Clinical Exercise Physiologist, CTE

"Cole Gunderson has been working as an exercise specialist at the Sherwood Park Primary Care Network for the last 7 years. He works to increase physical activity in people with chronic health conditions. Cole has also done work with the Edmonton Fire Department, Edmonton Police Service, Edmonton Oilers, and Edmonton Elks. He enjoys playing sports and volunteering in his community with the Strathcona County Rotary Club." The presentation will talk about fall prevention and include discussion about how to reduce the likelihood of falling in your home/workplace and ideas for exercises that may help improve strength and balance.

October 12, 2022 Special Provincial AGM There will be no Sherwood Park Strathcona County chapter meeting this month. November 15, 2022 Topic: What do Seniors Need in Strathcona County and How can this be Coordinated? Speakers: West End Seniors Association Team (More details to follow).

According to Haidong Liang, executive director of WE Seniors, who holds a PhD specializing in gerontology, recreation and community development, their goal is to establish mutual understanding and trust, and their first step will be listening to and understanding the unique needs of Strathcona County's seniors. 




Innovation, Science and Economic Development Canada (ISED) launched the *Connecting Families* initiative to connect low-income Canadian families to affordable home Internet service through various Internet Service Providers. Through the Government of Canada's Connecting Families initiative, participating Internet Service Providers (ISPs) are offering low-cost Internet to hundreds of thousands of Canadians. This initiative is administered by Innovation, Science and Economic Development Canada (ISED).

Seniors who are in receipt of the Old Age Security and are receiving the maximum Guaranteed Income Supplement (GIS) are eligible for this initiative and could receive low-cost high-speed Internet service at home. If they already have Internet service at home, they could still benefit from this offer. There are two options for them to choose from: "up to 50 Mbps download speed and 10 Mbps upload speed" with 200 GB of data for \$20 per month (plus tax); or a basic Internet service package of "up to 10/1 Mbps" with 100 GB of data for \$10 per month (plus tax).
